harassment and verbal abuse, it was mentioned that the complainant was being verbally abused, humiliated and mentally harassed by COO and Dr. Hazarika made derogatory comments about his medical competence and mentors.

The COO allowed government employed doctors of AGMC to perform duties at ILS Hospital during official hours violating the Tripura Government Notification for the year 2025 prohibiting dual employments.

A deceased patient's body was released without clearing hospital duties and the complainant was asked to take the responsibility. Besides, the complainant complained several mental distress due to continuous harassment and unofficial conduct by COO who allegedly runs the hospital as a business monopoly. The complainant stopped attaining duties from 14/10/2025 in protest though he has neither resigned nor terminated officially. The reliefs as sought for are that to order for immediate release of salary and benefits to the tune of Rs.1,50,000/- plus unpaid salary for two months and to take action against Dr. Goutam Hazarika for harassment and abuse of the authority and unethical practices and to make an enquiry into dual employment of the government doctors hospital and overall



managements.

"As per Rule 9 of the regulations of the Tripura Human Rights Commission, 2022, where a copy of the complaint addressed to some other authority is given to this Commission, the complaint should not be entertainable."

This being the position, since the complaint is addressed to some other authority, we are not inclined to entertain this complaint at this juncture. So, no action can be taken on the basis of this complaint and accordingly this case is disposed of.

Inform accordingly.
