## TRIPURA HUMAN RIGHTS COMMISSION KUNJABAN: AGARTALA Complaint No.129 of 2025

	4	The first incident was mentioned in respect of	
	5	Kadamtala Communal Violence incident happened in	
		October 2024. The Commission has already taken	
		cognizance on this matter. So, the Commission considers	
		that no separate complaint is required to be registered on	
		issue. Moreover, it is an incident of one year old.	
	·	The second allegation was regarding custodial	
		death and torture in respect of one U.T Prisoner namely	
		Badal Tripura. The Commission has also taken cognizance	
		on that issue and that matter is pending for final	
		recommendation. So, no need to take cognizance on that	
		matter.	
		The third point as raised in the deputation was in	
		respect of an incident occurred on 23rd October 2025	
	* 0	during 24-hours statewide bandh called by the Tiprasa	
		Civil Society resulting severe violence. It was mentioned	
		that bandh was organized to demand implementation of	
	A.	the Tiprasa Accord, introduction of inner line permit, and	

identification of illegal immigrants. It is alleged that in kamalpur Subdivision under Dhalai district, activists resorted to arson and looting, and 12 people were injured including Govt. officers and officials performing official duties. This Commission has not taken any cognizance on that matter.

The fourth allegation was in respect of violation of human rights of 323 Indian residences staying outside the Indo-Bangladesh border in Motinagar area. The Commission had already taken cognizance in respect of those persons. So no need to take cognizance in that aspect also.

The fifth allegation in respect of health care negligence and denial of treatment resulting death of one Modan Das due to denial of emergency medical treatment by staffs on duty but that information is cryptic in nature for which no inquiry can be conducted.

The sixth allegation is related to multiple incident of violation of human rights of some journalists. It is alleged that several journalists were assaulted and that allegation was also very cryptic. Even name of the journalists were also not disclosed date and time of the incident were also not mentioned. So, Cognizance cannot be taken on that issue.

The seventh allegation was relating to multiple internet shutdowns. It is alleged that Tripura experienced three internet shutdowns in 2024 restricting citizens freedom of expression and access of freedom and such an act restricts freedom of speech and expression as mentioned in Article 19 of the Constitution of India and

limits the right to internet access recognized under Article 21 of the Constitution of India. The Commission cannot take cognizance on that inssue which took place beyond one year as per section 36(2) of the protection of Human Rights Act. In that allegation, there is no mention about date when internet was shut down. So, this Commission cannot take any cognizance on that issue.

The eighth issue was relating to Women's Safety Concerns. The allegation relating to that category appears to be vague in nature. No specific instances are cited and as such the Commission cannot take any action in absence of providing specific information.

The point number nine relates to hate speech made in September 2024. It is alleged that in September 2024 police registered criminal case against two political party workers for delivering hate speeches. That incident also took place beyond one year. So, the Commission cannot take cognizance on that issue and section 36(2) of the protection of Human Rights Act 1993 is a bar to take cognizance.

The Tenth number allegation relates to one Madhabi Biswash. It is alleged that in October 2025 Smt. Madhabi Biswash was arrested for making derogatory comments on Facebook against the Prime Minister, Chief Minister, and other public figures. The Commission Considers that this matter is totally beyond the purview of this Commission and the matter is now pending before the police. This Commission has nothing to do regarding that aspect.

The last and final allegation was in respect of Ganda Twisa Violence in July 2024. One mob violence erupted in



the Tribal dominated Ganda Twisa Subdivision of Dhalai District following death of a person namely Parameshwar Reang, a 30 years old tribal youth who died from injuries sustained in an assault by a group from another community. The Commission already had taken cognizance regarding that matter. So, no need to take cognizance again regarding that incident. Moreover, that matter is more than one year old.

In view of the circumstances, the Commission considers that this Commission can only take the matter of violence held during October 2025 bondh as mentioned item no.3 of the complaint.

So, the Commission considers it appropriate to obtain a report from the DGP, Tripura regarding that matter before taking cognizance on the issue.

Accordingly, send a copy of the memorandum to the DGP, Tripura for inquiry report in respect of item number 3(three) of the allegations mentioned in page number 2 of the complaint. Information of the given by the complainants through officeal address. List the matter after 3(three) weeks.
